

E-Consent Parent / Guardian User Guide

To enrol a child on the Immunisations Consent Form there are a number of steps that must be completed. This quick guide will go through Enrolment and Consent.

A child is not registered until both parts are complete

Part 1 of 2 - Enrolment

Each child to be vaccinated must be enrolled. Enrolment ensures we can link and validate your child's immunisation with their NHS records. It also ensures that the person registering a child is their correct parent or guardian.

Type in their First Name, Last name and Date of Birth. The names should be the same as those used on their GP records.

Shortened names will not work e.g. Tom as a first name, if your child is registered as Thomas on their GP records.

Enter your child's NHS number or Gender

The quickest and easiest method is to enter your child's NHS number. This can usually be found on a recent prescription, GP letter or on the [NHS app](#)


If you do not recognise either of the numbers then select "I do not recognise any of these contact details" and press "Submit". → Go to Section B

If you selected “Send an email to *****@*****” you will receive an email from no-reply@inhealthcare.co.uk with a validation code.



Type the verification code from the SMS message or the email into the Verification Code box and press “Submit”.

Part 2 of 2 - Consent

In the consent section we will go through the steps needed to complete the form. The form has three parts. Validation, Consent and Allergy and Medication.

To complete this section, you will need:

- A school code provided by your child's school
- You child's date of birth
- The linked provided from the enrolment section

Validate using your child's date of birth

After opening the link provided via email or SMS you will be asked to enter your child's date of birth.

After entering the date, press "Login". You should then see the page below.

Thank you for filling out part two of the consent form. In this section we will collect your consent. We will also ask question regarding any previous immunisations or allergies your child may have.

You will be asked to fill out the consent declaration for your child's immunisations. On some vaccinations you may have to consent for each part of a vaccination.

If you want for your child to have the immunisation, select "I GIVE CONSENT" and type in your name.


If you **do not** want for your child to have the immunisation, select "I DO NOT CONSENT" and type in your name.

Allergy and Medication and submitting the form

Take a look at the Allergy and Medication section, Select “Yes” or “No” to each question. Pressing “Yes” will require you to give further details.

To Save this form press “Submit”. The form will not let you submit without all of the required fields having been completed.

If you press Submit and nothing seems to happen or the page scrolls back to the top of the page then there is something missing from the form.

Try checking the school's code is correct or look out for items highlight in red.



Vaccination E-Consent FAQ

Q) I am receiving self-enrol error 005

A) This means the details you gave do not match the data in NHS Digital's database. Please contact your GP and double check that ALL of your information is correct with them. Once that is done the GP system will update overnight and you will be able to try again.

Q) I am receiving self-enrol error 007

A) This means no contact details can be found. This might be because you have not registered these details with your GP practice. You can try again tomorrow when your information is updated with your GP practice.

Q) What is my school code

A) Each school should provide you with a school code. If you do not have a code then please contact the school office, they should be able to provide you with a code for your child's immunisation.
